1. A copy of MoRT&H letters No. RW/NH-33044/88/2021-S&R(P&B)/DNT(215840) dated 17 Jan 2023 and RW/NH-33044/88/2021-S&R(P&B)/DNT(215840) dated 18 Jan 2023 is forwarded herewith for your information and further necessary action please.

2. Vide above mentioned letter dated 17 Jan 2023, MoRT&H has issued amendment in Standard RFP and MCA of EPC as follows :-

(a) It has been mentioned in the Office Memorandum vide MoRT&H letter No. NH-35014/2020-H-Part(II)(E-196662) dated 16 Dec 2021 that Bidder is required to submit, alongwith its technical Bid, a self-certification that the item offered meets the local content requirement for 'Class-I local Supplier' / 'Class-II local Supplier' as the case may be. In case of procurement for a value in excess of Rs. 10 Crores, the Class-I local Supplier' / Class-II local Supplier' shall provide a certificate from the Statutory auditor or cost auditor of the company (in case of companies) or from a practicing Cost Accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.

(b) In this context, it has been decided by MoRT&H that if the above mentioned certificate has not been submitted by the bidder in its Technical Bid, an opportunity must be given to the bidder to submit the desired certificate during technical evaluation of Bid. In case the bidder is not able to submit the said certificate, further action may please be taken as per RFP.


