I am directed to convey the sanction of the President of India in partial modification to the provision of Govt of India Ministry of Shipping, Road Transport & Highways, Dept of RT&H, BRDB letter No. BRDB/04(224)/2006-GE-II dated 14 Jan 2009 as amended from time to time for payment of advance of Rs 50,000/- (Rupees fifty thousand only) as Immediate Relief out of Ex-Gratia Lumpsum Compensation to be paid to the NoK/Legal Heir of deceased /disabled CPLs who die in harness/sustained injury resulted into total/partial disablement while on Govt Bonafide duty. Initially the said amount of advance of Immediate Relief will be paid out of CPLs Welfare Fund of Project concerned and recouped subsequently on obtaining formal sanction of Competent Authority for payment of final Ex-gratia lumpsum compensation.
