NOTICE INVITING TENDER

1. A sealed tender is invited for **“PROVIDING, LAYING, SPREADING AND COMPACTION OF WMM 100 MM THICK AND WMM 75 MM THICK CONSOLIDATED WITH WMM PLANT MIX, DBM 50 MM THICK AND BC 30 MM THICK CONSOLIDATED WITH HMP MIX INCLUDING CLEANING OF ROAD SURFACE, APPLYING OF PRIME AND TACK COAT, LAYING AND ROLLING TO SPECIFIED COMPACTED THICKNESS FOR SURFACING WORKS BETWEEN KM 100 TO KM 114 ON ROAD DARRANGA-TRASHIGANG UNDER 63 RCC/ 19 BRTF, PROJECT DANTAK INSIDE EASTERN BHUTAN”**

2. Tender documents may be downloaded from BRO website www.bro.gov.in or Central Public Procurement Portal www.eprocure.gov.in and printout is to be taken on A4 size paper. It is advisable that the downloaded tender document to be printed through laser printer preferably. Submission of photocopy of tender is not permitted.

3. The estimated cost of work is **Rs 1034.00 lakhs (Rupees Ten crore thirty four lakhs only)** approximately or as subsequently amended in tender documents and uploaded in BRO website and Central Public Procurement Portal. This estimate, however, is not a guarantee and is merely given as a rough guide, and if work costs more or less, tenderer shall have no claim on that account of whatsoever nature.

4. The tender shall be based on Specifications, General Conditions of Contracts IAFW-2249 and rate contract for the supply of stores and materials based on IAFW 1779-A with Schedule "A" (List of works) to be priced by tenderers.

5. Not more than one tender shall be submitted by one contractor or one firm of contractors. Under no circumstances will a father or his son(s) or other close relations who have business dealings with one another, will be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both the parties liable to rejection.

6. The work is to be completed within **365 Days** or as subsequently amended in tender documents or uploaded in BRO website and Central Public Procurement Portal in accordance with the phasing, if any, indicated in the tender from the date of handing over site, which will be generally within one month from the date of issue of acceptance letter.

7. Tender documents will be available on BRO website or Central Public Procurement Portal wef **29 Dec 2017** and onwards.

8. The Chief Engineer (P) Dantak, C/O 99 APO will be Accepting Officer hereinafter, referred to as such for the purpose of this contract.

9. Tender (in full) either downloaded from BRO website or Central Public Procurement Portal will be received at HQ CE (P) Dantak , C/o 99 APO at **1200 hrs (BST) on 23 Jan 2018**. Part-I un-priced bid will be opened on **23 Jan 2018** at **1230 hrs (BST)** and date of opening of Part-II priced bid shall be intimated separately.

10. Intending tenderers are advised to visit BRO website/CPP Portal three days prior to date of opening of tender for any corrigendum/addendum/amendment. Tender received after due date shall not be considered for opening and no reason for delay or claim whatsoever shall be entertained.

11. The tender shall be accompanied with Earnest Money amounting to **Rs 8,42,000/- (Rupees Eight Lakh forty two thousand only)** in the form of Deposit at Call Receipt/Term Deposit Receipt/Special Term Deposit Receipt and Bank Guarantee Bond issued in favour of the Chief Engineer (P) DANTAK, C/O 99 APO by a Scheduled Bank. Tenders not accompanied with earnest money will not be considered for acceptance. The amount of this receipt should be basic amount and not their maturity value. Any deposit lying with the department in any form against any tender and/or contract shall not be considered for adjustment as the earnest money against this tender. Any tender not accompanied with the earnest money in the form as indicated here-in-before or accompanied with any letter/communication containing any request for adjustment of any other deposit as earnest money shall be treated as non bonafide tender. If an unregistered/un-enlisted firm revokes his offer (tender) after opening of bids within the validity period of his offer, the earnest money deposited by the firms along with his tender will be forfeited. Firms registered in BRO are not required to deposit EMD, but in case of revocation of the offer, firm has to deposit an amount equal to EMD.

12. The tenderer are advised to visit the site by making prior appointment with Commander, 19 Border Roads Task Force and OC 63 RCC, C/o 99 APO sufficiently in advance (Telephone No of Commander, 19 BRTF is **009755-252201**). A tenderer shall be deemed to have full knowledge of all relevant documents, local conditions, sites etc. For further details tenderer may contact telephonically if required, SW, Project DANTAK at **009752 – 351082/351086** during office hours.

13. A tenderer shall be deemed to have full knowledge of all relevant documents, samples, site etc whether he has inspected them or not.

14. Any tender which stipulates any alterations to any of the conditions laid down or proposes any other conditions of any description what so ever, is liable to be rejected.

15. The Accepting Officer reserves his right to accept a tender submitted by a public undertaking, giving a price preference over other tender (s) which may be lower, as are admissible under the Govt. policy. No claim for any compensation or otherwise shall be admissible from such tenderer (s) whose tenders may be rejected on account of the said policy.

16. The submission of tender by a tenderer implies that he had read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and local conditions and other factors bearing on the execution of the work.

17. Applicant/contractor have to attach a demand draft for **Rs. 3000/- (Rupees Three thousand only)** in favour of Accepting Officer i.e, **Chief Engineer, Project Dantak, C/O 99 APO and payable at SBI Hasimara (WB), Code No 1447 from any branches of State Bank of India** valid for three months with their application as the cost of tender forms/documents. All applicable bank charges shall be borne by the applicant and he shall not have any claim what so ever on this account from Govt. in case of re-tendering, the firms which has submitted the DD in earlier calls will require to submit DD along with their application again also. **Tender not accompanied with the cost of tender document is liable to be rejected.** However, Public Sector Undertaking/Govt. Undertaking firms are exempted from the payment towards the cost of tender documents.

18. The Demand Draft attached with the tender documents shall be non re-fundable if the tender documents are downloaded from the BRO website or CPP Portal and submitted by the contractor.

19. The applicant/contractor shall not become automatically entitled for issue of tender by virtue of enclosing Demand Draft along with the tender and the Accepting Officer shall reserve the right to deny issue of tender to any applicant/contractor.

20. In case of selective tendering or where inadequate applications are received suitable contractor may be selected and they shall also be asked to forward DD towards the cost of tender. Tenders will be issued to such contractors only thereafter.

21. The Accepting Officer does not bind himself to accept the lowest or any tender or to give any reasons for not doing so.

22. Tenderer who have downloaded the tender from the BRO website/ CPP Portal shall submit declaration along with tender document that I/we have downloaded the tender from website www.bro.gov.in, or www.eprocure.gov.in and I/we have not tampered/modified the tender form in any manner. In case if the same is found to be tampered/modified in any manner, I/we understand that my/our tender will be summarily rejected and I/we are liable to be banned from doing business with BRO.
